

**EASTERN MUSEUM OF MOTOR RACING 39th LATIMORE VALLEY FAIR
2024**

DATES: June 21 - 23rd Friday 4:00 PM -10:00 PM – Saturday 8:00AM -10:00PM – Sunday 9:00AM - 4:00PM

LOCATION: Latimore Valley Fair Ground, York Springs, Pennsylvania

PROMOTERS: Eastern Museum of Motor Racing

ENTRY FEE: FOOD - 15% OF GROSS SALES / GAMES 10% - There will be no additional costs such as lot rent, nor will buyers or spectators be charged an admission fee. The percentage of the gross will be **payable at the end of each night** at the green barn in the infield.

FLEA MARKET/CRAFT/EXHIBITOR - \$40 for a 15' wide space. Make checks payable to: "**The Eastern Museum of Motor Racing**" Return by May 30 to the address at the bottom of page 2. Refunds will be made only at the discretion of the Fair Board. Please provide a suggested menu. In order to avoid duplication of offerings, you may be asked to avoid items.

IT HAS BECOME NECESSARY TO ADOPT A SET OF RULES THAT ALL VENDORS MUST ADHERE TO. PLEASE READ THIS ENTIRE LETTER AND KNOW THAT WHEN YOU SIGN THE RELEASE FORM, YOU ARE AGREEING TO COMPLY WITH OUR RULES.

SET UP - The Annual Latimore Valley Fair will be held on the dates indicated above. The fair will be advertised on TV and radio. Posters, flyers and newspapers will also be utilized. Tables, A-frames, backdrops or any special display arrangements must be provided by the exhibitor. Spaces along the creek are 15 feet wide with varying depths. Spaces next to the track fence are 20 x 20 feet. Exhibitors may not use nails in/or harm the trees. Exhibitors are encouraged to set up by 3:30pm on Friday and 8:30am on Saturday and Sunday. Exhibitors may begin construction of their stands on the Sunday prior to the fair or may come any time during the previous week.

PARKING -During the fair vendor parking passes **MUST** be displayed to enter the vendor area. Cars may be taken to the display areas for loading and unloading. You are welcome to park on your spot if your vehicle fits. If not, you must remove it to the track on Friday night and on Saturday and Sunday, to either of the designated

There will be no exceptions. 'No parking' signs must be obeyed.

You are welcome to park a camper, trailer or any other means of conveyance, if it fits on your space. Make sure it does not extend over your neighbor's space. If it doesn't fit, you must rent another space or move to a larger space.

If you are not feeling well or exhibit any cold or flu symptoms, please stay home.

GENERATORS – The use of generators is permitted with these restrictions:
Generators must be kept to the back of your space and out of sight

- All generators must have a muffler
- Your neighbor should not be able to hear your generator
- Fair patrons should not be able to hear your generator
- Loud generators are not permitted

All decisions regarding generators are at the discretion of the Fair Committee. Your comments and suggestions regarding generator use are encouraged and welcomed.

POWER - Due to a limited amount of electrical power available, it is advisable to bring some source of lighting for the time that the fair is open after dark, Battery operated lanterns are suggested. The electricity furnished by the fairground may not be used by craftsmen, unless pre-arranged with the Fair Board.

CLEAN-UP - Exhibitors are responsible for cleaning areas before leaving the grounds.

Violators will not be asked to return. Pets are allowed, but you must clean up after them, or you will be asked to keep pets at home. Please consider the heat/weather when deciding to bring pets.

SECURITY - Members of EMMR and several craftsmen camp on the grounds nightly, which offers some security. However, security cannot be assured or guaranteed. Exhibitors are responsible for securing or protecting their property against theft or damage.

In order to ensure the success of the show, only artists and craft persons with quality products, and other dealers with attractive displays are asked to attend. The craft area is shared by household flea marketers and antique dealers. There are two options for these types of vendors, outside the track along the creek or in the tractor area. Please make sure to indicate which area you prefer. The swap meet area for car-related items is on the infield. We expect this year's fair to be another successful event and look forward to having you participate.

Vendors are encouraged to pick up their packets before the fair begins; Sunday between 2 & 4PM, Thursday evening or anytime before 4 Friday. THIS IS DONE IS SO YOU CAN GET YOUR VENDOR PARKING PASSES AND MAKE SURE EVERYONE THAT NEEDS ACCESS HAS ONE BEFORE THE EVENT. NOBODY WILL BE ALLOWED PAST THE BRIDGE WITHOUT A VENDOR PARKING PASS DURING FAIR OPERATING HOURS.

RememberCheck in with someone before you set up.
